Council reviewed the Floodplain permit application from the Lighthouse for improvements at their docks/bait house. Approval from DNR and USACE has been granted. Motion by Kinkead, second by Staake to approve the Lighthouse Floodplain Application as submitted. Roll call vote, all ayes, motion carried.

Motion by Staake, second by Schultz to approve Bills Boat Landing liquor license renewal. Roll call vote, all ayes, motion carried.

Council reviewed the FY 22/23 Budget. Funds were added to roads for culvert maintenance and to parks for potential projects. There was discussion about the water department that is currently operating at a deficit. Water funds have been accumulated over the years. Council suggested we budget an increase of \$5/ month for water. The water fund net income for FY 22/23 budget would be (\$3,695.44). Motion by Staake, second by Schultz to approve Resolution 2022-06 to set a public hearing for March 21, 2022 for proposed FY 22/23 Budget. Roll call vote, all ayes, motion carried.

Council reviewed a proposal for a Clayton, Iowa sign to be located on the riverfront shelter. There was general discussion on lights and previous signs on the riverfront. The parks committee will consider letter/font size and contact Iowa Prison Industries for pricing and layouts for council consideration next month.

Mayor reported that the leak detection was here ½ day, but unable to locate the leak due to snow. He will return after snow melts and all curb stops can be accessed. Council members are encouraged to notify the mayor or clerk if they are unable to attend a meeting to ensure a quorum will be present.

Motion by Staake, second by Kinkead to adjourn at 6:38 PM. All ayes, motion carried.
